TO OUR DONORS & FRIENDS,



As I write this letter, the U.S. Census Bureau reports that the number of Americans living in poverty swelled to 46.2 million people in 2010. The overall poverty rate reached 15.1 percent, matching the rate reached in 1993 – a year after I started my professional career as a graduate policy intern with Metropolitan Family Services. While much has changed

throughout the past 20 years for me, the daily challenges and struggles for the 1 in 6 Americans living at or below the federal poverty line have not.

In returning to Metropolitan Family Services – now to lead the organization – I am eager to bring a new perspective and to leverage the success and experience of Metropolitan's past to create new opportunities and innovative solutions that will enable our organization to serve the growing number of families in need.

These are difficult times. Economic turmoil, the state budget crisis and funding cuts have forced other area agencies to close their doors. However, thanks to the commitment and focus of Metropolitan's past and present leaders, staff and volunteers, the dedication and generosity of our donors, and the fiscal responsibility of our Board, we are financially sound and poised for growth. This agency is highly respected in the Human Services sector and recognized for our quality of services and strong client outcomes. Because our communitytailored programs and research-based approaches effectively address the persistent and emerging challenges families face, we continue to receive funding from our individual, corporate and community supporters.

Delivering human services in today's environment demands an unprecedented need for innovation, human capital and collaboration. We must step outside our comfort zone into new areas and seek formative approaches not only in the services we deliver, but in areas of advocacy and fundraising, administration and governance.

One example is the rise of mental health issues (including suicide) among our region's veterans and soldiers. This results in an increased need for many of the core counseling and mental health services we provide through our social workers, counselors and psychiatrists. As of July 2010, we have been approved to accept Tricare military insurance and serve an increasing number of veterans through our Southeast Chicago, Palos Hills and Blue Island locations. On the advocacy front, Metropolitan is leading the charge regarding the Illinois Predator Accountability Act of 2006 which allows survivors of sex trafficking to fight back against their abusers. Chicago has become a major hub for the lucrative sex trafficking trade yet in the five years since the act was passed not a single case has been brought to court. The Legal Aid Society of Metropolitan Family Services has established the Anti-Sex Trafficking Initiative which drives aggressive prosecution of sex traffickers. This initiative removes barriers enabling survivors to come forward and file civil suits for economic damages against their traffickers. It also provides access to the necessary social services such as counseling, housing and financial assistance and safety planning to support survivors throughout the litigation process. This Initiative is considered the missing ingredient needed to bring traffickers to justice.

In fundraising, we are aiming to build a larger, broader donor base to better support the vital services we provide. In the coming year, we will reduce the number of fundraising events we host and focus on cultivating relationships and building long-term individual, corporate and community partnerships.

As we look to the future we are again partnering with The Boston Consulting Group to develop a three-year strategic plan to position our organization for growth. This process will seek greater input and collaboration from our experienced staff – those involved with our clients and communities on a daily basis – allowing us to evaluate our infrastructure needs with new eyes. We are examining external factors including joblessness, decreases in family median income, causes of poverty and the increasing need in suburban areas.

Financial stability, effective programming and innovative thinking are all factors that drew me back to Metropolitan. They also have driven our sustainability for more than 154 years.

Last year we helped improve the lives of 43,000 families throughout the Chicago area and were again able to end the year with a balanced budget. All this is possible thanks to your generous support, our outstanding and caring staff and volunteers, along with the leadership of our Executive, Community and Young Professional boards. I ask that you continue to open your hearts to support those families and individuals striving for self-sufficiency and help strengthen the bonds of family. Together we can actualize positive outcomes for Metropolitan and more importantly for the communities and families we serve.





"I am so happy to be there, I never get bored. Tonight we made a folder for my homework so it doesn't get lost," says Jessica, age 10. She has been in the MetroMentors program for four years. Her mentor helps Jessica with homework. They play games together and go on summer outings. Regina, her single working mom, says the program helps her too, because it gives her a break to do things around the house and care for her younger son.



COUNSELING Provides support to individuals and families challenged with personal, phase-of-life and transitional issues.

James is pursuing a dream.

"Following a diagnosis in his early teens of ADHD by a counselor at Metropolitan's Youth Intervention program, James grew from a distracted and argumentative teenager to a college freshman with interests in literature and philosophy. Metropolitan helped James and his mom navigate the challenging high school years and counseled him through the sudden death of his father."



ECONOMIC STABILITY Provides support and education to economically challenged families so they may improve their quality of work, lifestyle and financial situation.

Tony gained valuable experience.

CHA Housing resident Tony mentioned his interest in working in security to his Housing Case Worker at the Calumet Center. Thanks to the 2010 "Put Illinois to Work" program, a transitional jobs program for qualified residents, Tony found temporary work at a local security company. The firm recently brought him on as a permanent employee. "They helped me go for interviewing and showed me how to do my resume. It made a real difference and gave me the work experience I needed."




LEGAL AID Provides legal assistance in the areas of domestic violence, family and elder law, housing and consumer issues to low-income individuals.



MENTAL HEALTH Provides psychiatric evaluation, case management and crisis intervention to help adults and children with chronic mental illness recover and be productive.

Jim is living independently.

Jim, 54, felt isolated and lacked the resources to cope with his schizoaffective disorder and other health issues. Metropolitan's casemanagement services enabled him to participate in group therapy and individual counseling, Jim recently moved into Metropolitan's Community Integrated Living Arrangement which he says is "The best thing that ever happened to me," as it provides him with an opportunity to be more independent and stay involved in family and community life.



OLDER ADULT SERVICES Provides counseling and caregiver respite to assist older adults and their families in meeting the challenges and opportunities of later years.

Mrs. May is aging with dignity.

Homeless, anxious and depressed, 63 year-old Mrs. May was unable to work due to emotional and medical conditions. Through the North Center's Senior Homeowners program, she found subsidized housing through a home share program, obtained needed medical care and is now receiving Social Security disability benefits. Counseling is helping her deal with unresolved issues and has improved her self-esteem and outlook on life.



PARENT DEVELOPMENT Supports parents in acquiring skills that promote the healthy growth and development of children.

Tonya is beating the odds.

By age 14, Tonya was the mother of two and was being raised by her grandmother in a crimeridden community. Her anger management counselor at *Metropolitan referred her to the* Mentors of Moms program at the *Calumet Center to learn parenting* and other important skills. Overcoming many challenges, Tonya graduated 4th in her class and received more than \$20,000 in scholarships to attend college. She is living in a family housing center with her children and receives onsite childcare.



VIOLENCE PREVENTION & INTERVENTION

Provides services to address violence in homes and schools to keep individuals and families safe.

Denise escaped violence.

Trapped in an abusive marriage, Denise sought counseling for herself and her children through Metropolitan's Family Violence Intervention Program. Through support and advocacy from the Legal Aid Society, the courts dissolved her marriage and granted orders of protection and temporary child support. They are living on their own and free from violence. Denise is employed and taking classes to improve her English. Her oldest daughter is enrolled in college and both girls are doing well in school.



REFERENCES

Last year refers to last fiscal year, which ran from July 1, 2010 to June 30, 2011. With regard to financial numbers, all outcomes and costs are approximate estimations based on available comparative data. In many cases the analysis should be considered conservative based on available comparative data and accounting for inflation.

1. Of the 971 adopted/State Guardian kids served in our Adoption Preservation (AP) program, only 11 children experienced a legal adoption disruption (child was returned to DCFS legal custody). Savings estimate based on daily and annual foster care cost estimates from DCFS, for every \$1 spent on a child in AP services with Metro, the State saves from \$7.92 to \$47.49 annually. Serving 960 children, Metropolitan saves the State \$15,222,888 to \$108,366,120 annually depending on level of foster care needed. These figures are based on DCFS' assumption that the great majority would have higher levels of care.

2. Since the inception of the program, Upward Bound has helped a total of 60 college-bound graduates secure \$1,616,373 in college scholarships. Last year 40 students graduated high school on time and 37 were enrolled into college and were awarded \$1,107,640 in scholarships. Scholarships include all monies awarded but not necessarily used.


