REGISTERING TO VOTE

Visit the Illinois State Board of Elections, www.elections.il.gov, or scan this QR code to register, check your status, and find your voting location for election day.



Voting Requirements

- ✓ Must be a U.S. Citizen
- ✓ Must be at least 18 years of age by Election Day
- ✓ Must have been a resident of the precinct for at least 30 days before Election Day
- ✓ Must not claim the right to vote elsewhere
- ✓ Must not be in prison, serving time for a conviction, on Election Day (returning citizens who have completed their sentences and who meet all other requirements listed above are eligible to vote in Illinois)



In case you forget...

You can also register in person on Election Day at your local voting site. Bring two forms of ID*, with at least one showing your current address. You must have lived in your precinct for at least 30 days prior to Election Day.

*No ID is required to vote in your home precinct on Election Day unless you are voting for the first time and registered by mail without verification.



KNOW YOUR RIGHTS

In Illinois, you still have the right to vote if you were previously incarcerated or convicted of a felony.

Those with felony convictions may need to reregister upon release.



If you are awaiting trial in a county jail with more than 3 million residents, you can vote onsite, if not, you can vote by mail. If you were in custody for a non-felony, your right to vote is automatically restored upon release.



Illinois allows same-day registration but it is highly recommended to do so a month before Election Day.





Where do I find information about voting for judges?

Every two years, voters go to the polls to elect new judges and decide whether to retain sitting judges.

16 & 17-YEAR-OLDS CAN PRE-REGISTER TO VOTE

Visit the Illinois State Board of Elections at https://ova.elections.il.gov, or scan this QR code to pre-register, check your status, and find your voting location for election day.



Voting Requirements

- Starting January 1, 2024, 16-year-olds may pre-register to vote online through the above link or QR Code.
- √ 16-year-olds will have their application held in abeyance until voting age.
- To vote in the upcoming 2024 elections, you must be 17 years old on or before the date of the Primary Election (3/19/2024) and turn 18 on or before the date of the General Election (11/5/2024).
- Must be a U.S. Citizen
- ✓ Must be at least 18 years of age by Election Day
- ✓ Must have been a resident of the precinct for at least 30 days before Election Day
- Must not claim the right to vote elsewhere
- Must not be in prison, serving time for a conviction, on Election Day (returning citizens who have completed their sentences and who meet all other requirements listed above are eligible to vote in Illinois)



You can also register in person on Election Day at your local voting site. Bring two forms of ID*, with at least one showing your current address. You must have lived in your precinct for at least 30 days prior to Election Day.

CHICAGO SCHOOL BOARD ELECTION GUIDE 2024



WHAT DO SCHOOL BOARD MEMBERS DO?

- Hire & evaluate CEO
- Establish the direction, goals, and priorities for the district
- Approve district policies
- Approve purchasing decisions, contracts, and intergovernmental agreements
- Approve the district budget and capital improvement plan
- Approve the school year calendar
- Approve school continuous improvement plans, school actions, and school charters and contracts
- Approve the dismissal of probationary appointed teachers, contract principals and tenured teachers, and non-probationary educational support personnel

For the first time on Tuesday, November 5, Chicago voters will elect their school board members. Before this point, the board has been entirely appointed by the Mayor of Chicago.

HOW IT'S CHANGING

- This November, 10 of the 21 school board members will be elected. The rest will still be appointed, resulting in a transitional hybrid board. In November 2026, the entire board will be elected.
- Voters will select from the candidates in the district in which they live. Each district is split into subdistricts (A and B). If voters select the candidate from subdistrict A, the mayor's appointed second candidate will come from subdistrict B (and vice versa).
- Candidates needed to file 1000 valid signatures of registered voters in their district by June 24 in order to be eligible.

WHAT YOU CAN DO

- Ask your candidates questions! Do they know what the role of the board is? What will they do to make it effective? How do they plan to engage with their community and collaborate with others?
- Make a plan to vote!
- Share your opinions! Let your board members know what your priorities are for the school district in which you live. Hold them accountable to do what is best for students.

Vote by mail: starting Wednesday, August 7
Vote Early In-person: starting Thursday, September 26
Vote at permanent polling locations: starting Monday,
October 21

Unhoused Voter Guide

All people experiencing houselessness have the right to vote in every local, state, and national election.

REGISTERING TO VOTE:

Everyone registering to vote (at an early voting site or on the day of an election) needs 2 forms of identification, including one that shows proof of residence.

In place of this, an individual experiencing houselessness may provide a letter from any of the following:

- 1. A drop-in center
- 2. A shelter
- 3. The person in whose home they are living doubled-up

This letter must confirm that the named person has permission to use the address to register to vote.

SITUATIONS WHERE ID IS NEEDED:

- They registered by mail and didn't include their Illinois ID/driver's license number or Social Security number.
- An election judge challenges the person's right to vote.

(A common reason why this occurs is that the Board of Elections sent mail to verify a voter's mailing address, but the mail was returned.)

 The individual is registering to vote onsite (see above)



IF AN INDIVIDUAL... IS UNABLE TO SHOW ID

They may still cast a provisional ballot. For it to be counted, the voter must present ID within seven days of the election to the Board of Elections.

MOVED RECENTLY?

- Within the same precinct and within 27 days: sign an affidavit and vote a full ballot!
- Outside the same precinct and more than 30 days ago: update their registration through voting day and vote!
- Outside the same precinct and less than 30 days ago: update their registration through voting day and vote! OR sign an affidavit and vote a full ballot at their old polling place!
